Facilitated RD&I Steering Meetings: A Service to Strengthen Innovation Capability



That foundation allows us to offer something more: RD&I Steering Meetings that lift the conversation from operational updates to strategic decision-making, and that build leadership capability over time.




RD&I Steering Meetings - Driving R&D and Innovation without the Burden

Each agenda is built and shared through the ReaDI-Watch platform, where it connects directly to interview transcripts, captured evidence, and the company's broader RD&I roadmap.

For many teams, **just having the meeting in the calendar makes a difference**. It creates a natural checkpoint—a rhythm of accountability—so progress happens steadily without leaders having to push it forward themselves.

Our role in the meeting is twofold: we act as a support function, removing the burden of coordination and tracking,

and we step in as a **fractional RD&I leader**, prompting the right questions and behaviours. By doing so, we help clients build the internal rhythms and habits that strengthen their innovation culture—and we do it using their own live data.

After each meeting, all notes, actions, and decisions live in the ReaDI-Watch platform—tied back to the projects, people, and priorities they relate to. This removes the need for scattered updates or offline tracking. Teams have a single, shared reference point for what was discussed, who owns what, and how progress will be followed up.

More importantly, clients aren't left to manage this themselves. We handle the lift—agenda setup, meeting facilitation, action capture—so they can focus on the conversation. Over time, this creates a rhythm that is not only easier to maintain, but also more strategic and accountable. And for companies aiming to mature their RD&I function, it's a powerful way to build internal capability while staying focused on delivery.
